Subject: Wycombe District Local Plan Review And 'The Key to the Future' Questionnaire (attached)

GUEST SPEAKER is Mr. David Turner, Head of Planning Policy and Economic Development for Wycombe District Council

Once more your open countryside is under threat of building development.

Because you fought back you helped stop Mobil's proposed Motorway Service Area in 1990 and again in 1995.

Your designated 'Chilterns Area of Outstanding Natural Beauty' (AONB) at Sands is under investigation for housing development. (Society Newsletter of May 1996 warned of looming dangers to your local environment and one of them is now imminent).

If this is allowed to happen your AONB at Booker will become vulnerable by reason of precedent and it would be foolish to imagine that Mobil will not take advantage of the precedent and Appeal for an MSA for the third time. (The Government Planning Policy Guide No. 7 (January 1992) para 3.9 says ".... Only proven national interest and lack of alternative sites can justify an exception (to AONB protection policies)".

This exception to the general rule of AONB Policy would be supported by the precedent of an exception to the rule in the local interest of housing development.

Many Society members and supporters resident in Arundel Road, Carisbrooke Avenue, Rydal Way and Warwick Avenue are "gagged" from objecting by reason of a covenant attaching to their individual properties. (This surprising fact has emerged from the Society AGM on 20th May and the Society took legal advice).

It is therefore doubly important that everybody else objects in order to close the gap of loss of several hundred objectors, through no fault of their own.

YOUR COMMITTEE CALLS ON EVERY MEMBER AND SUPPORTER FOR "ACTION THIS DAY" BECAUSE EVERY VOTE COUNTS.
